NOTES, TERMS & CONDITIONS

Important information concerning bookings, terms, deposits, balance and cancellation policy.

§1 BOOKING

Bookings are conditional on you, the client, signing the Release Form following Paragraph 5 below before your departure to Uganda.

§2 RESERVATIONS AND PAYMENTS

Safaris are booked and confirmed only upon receipt of a 50 % deposit of the basic safari rate or the listed payment schedule in the safari information sheet. There shall be no binding contract until the deposit has been made. Failure to remit your deposit on time may result in an automatic release of the confirmed space and /or time of your safari. When Uganda Wildlife Safaris Ltd. receipts in writing of the deposit to you, it shall be deemed to constitute accept ance and confirmation of the reservation. All payments are to be in US \$. Personal checks will be accepted for initial deposits only.

§3 CANCELLATIONS AND REFUNDS

A 50% non-refundable deposit is required to hold space plus a signed safari agreement. The balance of the daily rate or package price is to be paid ninety (90) days before commencement of your safari.

If Uganda Wildlife Safaris Ltd. cancels or delays a trip, or the trip is interrupted while in progress, the following provisions will occur due to the difficulties of operating in Africa: A delayed trip due to transportation company rescheduling or inability to operate, equipment breakdowns, strikes, weather, lost luggage, lost guns, revolt, coup, terrorist act, African government changes, war, rebel incursions, embargos, no fuel available or acts of God do not constitute a cancellation by Uganda Wildlife Safaris Ltd. but rather a delay in the trip and the client agrees to accept a credit towards a future trip operated by Uganda Wildlife Safaris Ltd. at the same location or another location owned/operated by Uganda Wildlife Safaris Ltd.

Any extra expenses incurred by the participant, such as extra hotel, taxi, food, laundry, tips, liquor, water, airline penalties, airline tickets, Charter costs, pre-trip costs such as visa costs, cost of leaving your home, special purchases for the trip, lost vacation time or other damages due to a delayed trip, trip interrupted while in progress for any reason, or failure of a supplier in Africa to honour arrangements, will not be credited or cash refunded to the participant.

§4 RISKS

Uganda Wildlife Safaris Ltd. draws your attention to the fact that there are certain inherent risks involved in participation in the type of trips and/or safaris sold by Uganda Wildlife Safaris Ltd. and that you accept them at your own risk. Uganda Wildlife Safaris Ltd. cannot be held liable for any personal injury or property damage which may arise out of these or any services. It is your sole responsibility to take all appropriate medical advice prior to departure. Uganda Wildlife Safaris Ltd. shall not be liable for illness, injury or death sustained on a program sold by Uganda Wildlife Safaris Ltd.

§5 FORCE MAJEURE

"Force Majeure" means, in relation to Uganda Wildlife Safaris Ltd., any circumstances beyond the control of Uganda Wildlife Safaris Ltd. including, but without limitation, acts of God, explosion, flood, tempest, fire, or accident, war or threat of war, sabotage, insurrection, civil, disturbance, or requisition, sickness, quarantine, government intervention, weather conditions or other outward occurrences. Uganda Wildlife Safaris Ltd. is not responsible for Force Majeure.



AGREEMENT

RELEASE OF LIABILITY AND ASSUMPTION OF RISK. AGREEMENT CONTAINS PROVISIONS WHEREBY YOU RELINQUISH CERTAIN RIGHTS: PLEASE READ CAREFULLY. I, understand that I am required to carefully read and sign a RELEASE OF LIABILITY AND ASSUMPTION OF RISK form before my arrival in Africa.

By paying a deposit I understand the terms and conditions as laid out by Uganda Wildlife Safaris Ltd, and under stand that this deposit confirms my safari arrangements and booking with Uganda Wildlife Safaris Ltd. I understand that it is my responsibility to ensure that passports, visas, travel permit, health certificates, inoculations or other documentation required are obtained, current and in order. Uganda Wildlife Safaris Ltd. advises me to obtain the following types of insurance which I understand are commercially available; Accidental Death and Disability – Major Medical – Emergency Medical Evacuation – Loss of Personal Effects – Trip Cancellation.

I understand the risks involved in hunting dangerous and non-dangerous game, the harshness in wilderness habitat and other forces of nature, all which are beyond the control of Uganda Wildlife Safaris Ltd.! I am aware that adven ture travel, whether in civilized or remote area, by automobile, plane, train, boat, other conveyance, or on foot, contains inherent risks of illness, injury, death, or loss and damage of property, which may be caused by negligence of others, forces of nature, and other causes known or unknown. I recognise that such risks may be present at any time before, during and after the trip I am participating in under the arrangements of Uganda Wildlife Safaris Ltd., their owners, officers, the PH, employees and/or their agents. I am also aware that medical services or facilities may not be readily available during the time I am participating in this trip.

In consideration of the payment of the required deposit and balance of fees when due, as well as the right to participate on "the Hunting trip" and the activities, services, and food arranged for me by Uganda Wildlife Safaris Ltd., its employees and/or agents, I declare as follows:

I have read all of the foregoing and fully understanding, agree to the contents thereof and assume any risks associated with "the Hunting trip" for myself, as well as for any minors accompanying me.

I expressly agree on behalf of myself, and on behalf of any minors who accompany me, to hold Uganda Wildlife Safaris Ltd. and their owners, officers, the PH, employees and/or agents harmless and free from any and all liability for any accidents resulting in death, dismemberment, disability and/or injuries of any nature and kind whatsoever, damages, losses and/or claims including loss of and/or damages to personal property, to myself and any minors who accompany me, which may be caused directly, indirectly, accidentally, intentionally or negligently, by any officer, owner, the PH, member, employee and/or agent of Uganda Wildlife Safaris Ltd., during the course of "the Hunting trip".

I further expressly agree on behalf of myself and any minor who accompany me on "the Hunting trip" that the terms, conditions and provisions of this contract will be binding upon me personally and any members of my family including my wife, if any, as well as my heirs and any executors, administrators and /or representatives of my estate.

I further expressly agree on behalf of myself and any minor accompanying me not to challenge the legality of this contract. This will be binding upon me personally and any members of my family including my wife, if any, as well as my heirs and any executors, administrators and /or representatives of my estate.

This contract is governed by the laws of Uganda and legal jurisdiction for any dispute is in the country of Uganda.

The responses provided by the company and the client herein are true and accurate, and each party has the right to rely upon the information (Booking Information Sheet and Safari Schedules) as a basis for this agreement. Further, both parties acknowledge that the responses set forth herein shall constitute part and parcel of this agreement.

- 1. Uganda Wildlife Safaris Ltd. represents and warrants to the Client that it is duly licensed by all applicable national and local authorities to conduct the hunt described herein and that it will conduct such hunt in accordance with all national and local laws, rules, and ordinances applicable to the hunt.
- 2. Licences and/or Permits from the client's country of origin are the sole responsibility of the client.
- 3. Licences and/or Permits from the country and locality in which the hunt takes place are the responsibility of Uganda Wildlife Safaris Ltd. to obtain on behalf of the client.
- 4. It is understood that this contractual agreement does not constitute or imply any guarantee by Uganda Wildlife Safaris Ltd. that a particular species of animal will be obtained by the client. However, it is fully understood that P.H. and Uganda Wildlife Safaris Ltd. will make every reasonable effort to place the client in an area and position where the animal sought could be taken.
- 5. All payments to Uganda Wildlife Safaris Ltd. in Uganda (except bank deposit or wire transfers) must be made in cash
- 6. A 50% non-refundable deposit is required to hold space plus a signed safari agreement. Balance due 90 days prior to arrival in Entebbe.
- 7. If, for any reason, the client fails to arrive in the company's camp as scheduled, no adjustment or compensation will be made except at company's discretion. In case client's failure to arrive is due to client's death prior to the start

of the safari and company is notified of such circumstance, then 50% of all the moneys on deposit will be credited toward a future trip with and at the discretion of Uganda Wildlife Safaris Ltd. to be used by your designated heir or replacement.

- **8.** Flight delays client agrees to communicate with Uganda Wildlife Safaris Ltd. immediately about any delays of arriving on schedule for the safari departure so that appropriate steps can be made for the client to catch up with the safari, if at all possible.
- **9.** If for any reason the client chooses to depart at an earlier date than scheduled, such early departure shall be at the clients own expense and liability, without adjustment or compensation.
- **10.** Any/all trophies, capes or other items shipped to the client's port of entry will be shipped prepaid at the client's expense and will include all Crating and shipping charges.
- 11. Uganda Wildlife Safaris Ltd., officers, owners, the P.H. and their respective employees shall maintain all reason able care and precaution for the safety of the client, but the client recognises that he/she is taking part in an outdoor activity involving inherent risks. The client accepts such inherent risks, assumes the liability for the same and holds the company, the P.H., their respective employees, and agents harmless from any damage and expense.
- **12.** Jurisdiction: It is agreed by both parties that this contract shall be governed, interpreted, and enforced pursuant to the law of the country, state, province, and locality in which the hunt takes place.
- **13.** Any changes or alterations to this agreement must be made in writing and signed by both parties. This agreement is executed by the signatures of both parties who have read and understand this agreement and accept its **t**erms:
